ISSUE OF CLEANSING NOTICE UNDER SECTION 708A CORPORATIONS ACT

NOVONIX LIMITED (ASX Code: NVX) has today issued 250,000 fully paid ordinary shares in NOVONIX Limited (NVX) (**Shares**) on the exercise of 250,000 options at an exercise price of \$0.80 per share.
